DIRECTIONS FOR USE ON GREENS

GENERAL TURF MAINTENANCE: Apply 12 lbs. per 1000 sq. ft. at a 8 to 12 week interval to optimize color and growth. A 6 lbs per 1000 sq ft at a 4 to 6 week interval offers enhanced turf quality.


AFTER AERATION: Apply 12.5 lbs per 1000 sq ft after aeration for turf recovery and root development.

IN THE FALL: Apply 12.5 lbs per 1000 sq ft as a late fall application for root development and outstanding spring color.

TURF ESTABLISHMENT: Apply 25 lbs per 1000 sq ft as a seedbed preparation incorporated into the top 4 inches.

COLOR BEDS & BULBS: Incorporate 25 lbs per 1000 sq ft prior to planting to enhance establishment. Apply 12 lbs per 1000 sq ft every 45 to 60 days for continued summer blooms.
