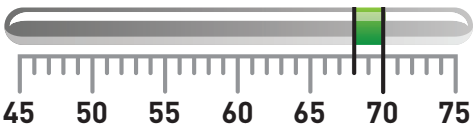

DIRECTIONS FOR USE ON GREENS

FOR GENERAL TURF MAINTENANCE PROGRAM:

Apply 10 lbs. per 1000 sq. ft. at a 12 week interval to optimize color and growth. During periods of stress apply 5 lbs. per 1000 sq. ft. at a 6-week interval.
