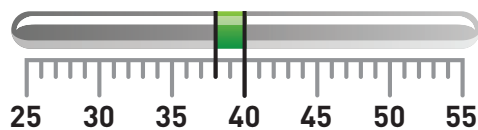

**GOLF FAIRWAYS AND ROUGHS:** Apply 5 bags/A of product every 12 weeks for general turf maintenance and soil health. A higher rate needs to be applied to guarantee good coverage.
