DIRECTIONS FOR USE

BULB PROGRAM: Pre-Plant Program: Apply Sanctuary 8-8-8 at 2 to 4 ounces per bulb mixed into the planting soil to fill the hole.

Maintenance Program: Apply Sanctuary 8-8-8 at 1.0 lb. per 100 square feet after bloom fade and in the late fall.

FLOWER BED & GROUND COVER PROGRAM:

Pre-Plant Program: Apply Sanctuary 8-8-8 at 2.5 lbs. per 100 square feet incorporated into the top 2 to 4 inches of the soil prior to planting flowers.

Maintenance Program: Apply Sanctuary 8-8-8 at 1.0 lb. per 100 square feet in the spring and fall using a hand held spreader.

TREE & SHRUB PROGRAM: Pre-Plant Program: Apply Sanctuary 8-8-8 at 2 to 4 lbs. into the bottom of the hole. Plus, mix 2 lbs. per tree caliber inch into the soil backfill material to fill the hole.

LAWN ESTABLISHMENT PROGRAM: Pre-Plant Program: Apply Sanctuary 8-8-8 at 25 lbs. per 1000 square feet incorporated into the top 2 to 4 inches of the soil prior to sprigs, sod or seed.

AERATION PROGRAM: Maintenance Program: Apply Sanctuary 8-8-8 at 10 lbs. per 1000 square feet after aeration.
