Residential Lawn Care	8 oz to 16 oz per acre per 8 weeks
Sod Production	8 to 16 oz oz per acre per month
Fairways & Sports Turf	16 oz per acre per month
Green & Tees	16 oz to 32 oz per acre per month
Combination Tank Mixing	12 oz to 16 oz per acre per month
Calcium Impregnation	40 oz to 64 oz per ton
Fertilizer Impregnation	64 to 128 oz per ton
Fertilizer Injection	8 to 16 oz oz per acre per month

## ORNAMENTALS APPLICATION RATES

ORNAMENTALS	APPLICATION USE RATES
Flower Installation	Mix & Drench Roots Zone with 4 oz per 5 gallon of water
Tree & Shrub Installation	Drench root ball or container with 4 oz per 5 gallon of water
Tree & Shrub Maintenance	Drench plant root zone with 64 oz product in 100 gallons of water
