Apply monthly at a rate of 3.5 lbs/M during the golf season to promote residual turf color. This program can complement with the use of liquid fertilizer products.

#### **TURF RECOVERY:**

Sanctuary can be applied any time when the turf is under stress. For turf stress, the rate is 4 lbs/M. For after aeration apply 6 lbs/M to promote turf recovery.

#### **DORMANT FEED :**

In the late fall, Sanctuary can be applied at a rate of 6 lbs/M for rooting, recovery, winter stress tolerance and spring green up.
